a) Internet connection

Education Partnership Program

- in Ontario the sums go to Nishnawbe Aski Nation, there is a lot of information on the Internet about the program: Google (INAC Education Programs- Education Partnership) stating that:
- If the goal is to increase literacy, math, perhaps the Board can offer communities to help them apply for the program
- Approach the communities and ask them if they need help applying for more services
- All the programs are for those who live on the reserves only. At times reserves don't know about these opportunities, leaders and workers often change so the next person is not aware.

- b) **INAC** has increased the special education dollars for reserve schools, have been able to hire behavioral specialists including for autism, two people work one week a month with the students, teachers and individual parents, as well hiring a psychologist to work with the most demanding students once a week. The psychologist also works with the guardians/parents.
- c) Possible partnership next year with District School Board Ontario North East and have someone work with Kiwetin on literacy.

Special Education Plan

Steve Pladzyk, Superintendent, shared the changes being made to the 2016-17 Special Education Board Plan.

Action: members will be-mailed document once it has been finalized.

Discussion ensued on ongoing revision of the document and the importance of having Mental Health in alignment with the Special Education Plan, discussion on the IEP assessment process followed.

Special Education Team Updates:

Steve Pladzyk, Superintendent, provided updates which included **Vanessa Harmanmaa**, Acting Autism Support Officer who reported on obstacles regarding implementing the Autism After School Program. As a result the program will only be offered at a Secondary level this year. Funding will be carried over to the next school year.

- Staffing preliminary level, reviewing schools, services and needs, gathering of data
- March 8 motion to the Board "Superintendent to provide a report on the Psycho-educational

 next board meeting
